**REPORT ON THE FINANCIAL STATEMENTS**

We have audited the accompanying financial statements of **TECHNOULTRA ENGINEERS PRIVATE LIMITED** ("the Company"), which comprise the Balance Sheet as at March 31, 2024, the Statement of Profit and Loss (including other comprehensive incomes), and a summary of the significant accounting policies and other explanatory information.

## **OPINION**

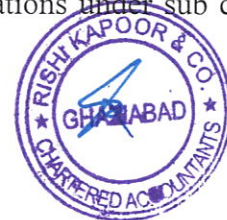

  - c) The Balance Sheet and Statement of Profit and Loss dealt with by this Report are in agreement with the books of account;



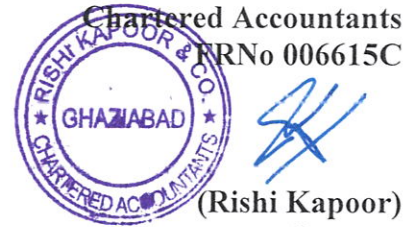
